16 **Regulations; Amending Sections 17-1 — Purpose and Intent, 17-2 — Permitting**  
17 **Requirements, 17.3 — General Requirements, 17-4 — Permanent Signs, 17-5 — Temporary**  
18 **Uses And Special Event Signs, and 17.7 — Prohibited Signs (Thad Carroll)**
