1. Only vendors with completed and approved applications may utilize the Lady Lake Farmer's Market. Applications are to be completed on an annual basis, expire on September 30th, and require the completion of the following:
 - a. Reading and understanding all rules, policies, etc.
 - b. Signature of potential vendor and date of signature
 - c. List of all produce, other food products, and hand-crafted items intended to be sold
2. Advertised Market Hours are every Tuesday from 9 AM-2 PM. The months will be from October to May.
3. Once an application is completed and received, it must then be approved by the Town of Lady Lake or its designated representative(s). Once approved, the vendor will be able to vend at the market.
4. Reselling of produce and other approved food products is allowed so long as vendors clearly display, at all times, signage showing where the current produce or products being sold were produced and who produced them. Vendors are subject to relevant inspections to verify the source of their produce and products.
5. It is at the discretion of the vendors to market their produce and other products at the prices they see fit.
6. Vendors must always keep their areas clean and orderly and ensure there is no trash, signage, boxes, vehicles, trailers, or other personal items left on the premises. The Lady Lake Farmer's Market nor the Town of Lady Lake will be held responsible for lost, stolen, or misplaced items.
7. Only fruits, vegetables, & other homemade products will be allowed.
8. HANDCRAFTED ITEMS: These items can be sold SO LONG AS they are crafted by hand and sold by the vendor.
9. Only service animals will be allowed at the Lady Lake Farmer's Market. No other animals are allowed.
10. All tents must be weighed! There are no exceptions to this rule!
11. All vendors must act and behave in a manner that will reflect positively on the Lady Lake Farmers Market. Gossip or openly criticizing the Market will not be tolerated. Violators of this rule will be expelled from the Market. If there is an issue, please speak to the Lady Lake Parks and Recreation Department.
12. All vendors are to follow the rules of the park, Market, and the Town of Lady Lake. Violating the rules will not be tolerated and may be grounds for expulsion from the Market.
13. All trash will be removed from the property. No using Town dumpsters or trash cans to toss away any vendor's refuse!
14. These rules and policies are subject to change by the Farmer's Market/Parks and Recreation Department at any time. The Farmer's Market reserves the right to deny or revoke a vendor's application and permission to use the premises at any time and for any reason without discourse.
